- The hostel accommodation will be given to the students on the merit basis and as per seats allocated department-wise by the Institute Authority.
- 2. The students who are allotted seats in the hostel will have to continue for full session.
- 3. The Institute will provide sharing accommodation with cots, chairs and tables to the hostellers. However, the bedding, linen, tumbler, thermos, bucket, etc. will be brought by the student. The students will be responsible for the up keep of the Institute property and the articles issued for use in the hotel, any type of damage to the property/articles, the cost will be recovered from the students.
- 4. The hostlers are not allowed to keep any valuable articles such as jewelry, heavy cash, expensive electrical/electronic gadgets etc. in their rooms. The Institute under no circumstances will be responsible for the loss of any valuable articles, however Any hostellers found to be violating of the above rules will be liable for disciplinary action.
- 5. Consumption of alcoholic drinks, drugs and gambling are prohibited. Bottles other than plastic are not allowed to be kept in the room. Objectionable materials (magazines/cassettes/CDs/Weapons etc.) are not allowed to be kept in the hostel room.
- 6. All hostellers should carry their identity cards issued by the Institute, even while going out or to the mess during free times the students are not permitted to wander in the other parts of the Institute building.
